CONTRACT Between \_\_\_\_\_  
Herein called the "Exhibitor" and the Guelph Lions Club herein called the "club"

The Club is the organizer of a Home & Leisure Show, to take place at the West End Rec. Centre April 20, April 21st and April 22<sup>nd</sup> 2017. The Exhibitor desires to take part in this Show by renting space from the club during the period of the show. The Exhibitor and the Club agree as follows:

1. The Exhibitor agrees to rent space(s) at the specified fees. The fee is \$500.00 per standard space 10' X 10'. The fee for a double space 10' X 20' is \$ 900.00 and a 10' X 30' space is \$1,300.00. The standard space in the main ring includes electrical connections, curtains, web listing and inclusion in all our advertising.
2. The space selected for the exhibitor on the floor plan of the arena or hall can only be confirmed by the Club once payment is received in full. Exhibitors must have payments in by March 27, 2016 to ensure a booth(s) reservation. There is **no** refund in the event of the Exhibitor cancelling.
3. The Exhibitor is responsible for the security of their goods against all perils; at all times; during set-up and take down of their display, as well as during the show.
4. The Exhibitor agrees to staff their display at all times during the Show hours, as specified during the Show schedule. Arena will be locked nightly
5. The Exhibitor may set up Thursday, April 20<sup>th</sup> 6 AM. to 4 p.m.,. No vehicles or carts after aisle carpets have been laid.
6. The Exhibitor will have until 12 Am on the 22<sup>nd</sup> to take down their display, but must not begin before set time for closing the show.
7. The Exhibitor is responsible for removing all goods and materials from the arena or hall after the Show and leaving the space rented in a clean and orderly state. The Exhibitor will be billed for the removal of any goods left behind and for cleaning the rented space if it is not done.
8. The Exhibitor is responsible for its own multi peril and public liability insurance to protect itself, its employees and its display at the Show and the Exhibitor agrees to reimburse the Club for any amounts paid out and costs incurred by the Club as a result of any liability claim for which the Exhibitor is responsible.
9. The Club agrees to promote the Show throughout Wellington County and the City of Guelph.
10. In the event the Show is cancelled for any reason, the Club will return the amount paid for the space and shall not be liable for any additional expenses incurred by the Exhibitor or for profit expected to be gained from the Show.
